Through the generosity of our donors, we are happy to report that .ORG Foundation went from a simple idea shared by three junior Marine Corps Officers to a fully established organization. We amended our articles of incorporation and nonprofit corporate license. We created bylaws that define the purpose and structure of our organization. We built our website including a portal to securely process online donations. We applied for and were granted federal income tax exemption status by the Internal Revenue Service (IRS). We held our first two small charitable events in support of wounded fellow U.S. service members:

- Oct 2012: 10K Marine Corps Marathon Run Fundraiser for the Wounded Warrior Project
- June 2013: Donation to the Navy Marine Corps Relief Society

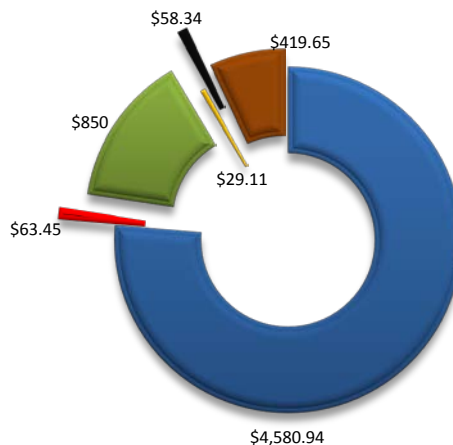
